He enrolled immediately for a master degree programme in Architecture and obtained a Distinction in Design on completion of his M.Sc. (Architecture) degree in 1984. Jagunna is a registered member of the Architects Registration Council of Nigeria (ARCON-F/685) and a Corporate Member of the Nigerian Institute of Architects (NIA-M/770) since 1988 – thus becoming one of the few alumni architects of the Department of Architecture, Obafemi Awolowo University, Ile-Ife, to be so registered that year, under the full membership categories of the two bodies. Arc Biodun Jagunna belongs to several other professional bodies such as being an Associate Member of the Nigerian Institute of Management (NIM), Member, Association of Consulting Architects of Nigeria (ACAN-ACA/013/05) and an active member of the Lagos Chapter of the Nigerian Institute of Architects.

He also actively participated as the Chairman of the Lagos State Urban and Physical Planning Law Review Committee of the Chapter in 2001. Consequently he received the State Chapters honors' in 2004. He is currently the Chairman Practice Committee of the Chapter and has been a member of NIA Practice Committee since 2010. He is also a resource person to NIA Lagos State Education Committee where he administer Oral examinations and helps with the invigilation during Professional exams. As a professional Architect, Arc. Jagunna had a brief stint in July 1979 at Messrs Co-Operative Architects in Trieste, Italy on a Students and Staff Exchange Programme. After graduation, he worked with Messrs Ibru Vaughan-Richards and Associates (IVRA) under the supervision of Late Arc Alan Vaughan-Richards and Arc Felix Ibru, both Fellows of the NIA. At IVRA he was actively involved in design, preparation of working drawings, contract documentation and supervision of several projects which included, Faculty of Social Sciences, University of Nigeria, Nsukka; University of Benin Master plan, and Accident Centre; Psychiatric Hospital, Complex, Oshodi, Lagos; Blocks of Flats for the Psychiatric Hospital Yaba, Lagos; Lagos Sheraton Hotels and Towers (Supervision), Extension to Rutam House, Isolo; Opebi Gateway Extension to Lagos Sheraton Hotels and Towers, Lagos; Nigeria Television Authority (NTA) Production Centre, Port-Harcourt; the Liberation Stadium, Port-Harcourt; and several others.

At Bior-Jag, he has handled several projects ranging from Planning Projects; Educational; Institutional; Commercial and Industrial Projects. Others include Residential, Recreational, Hotel, Hospital/Health-Related Projects, Religious and Residential Estate Projects across the entire landscape of Nigeria.
